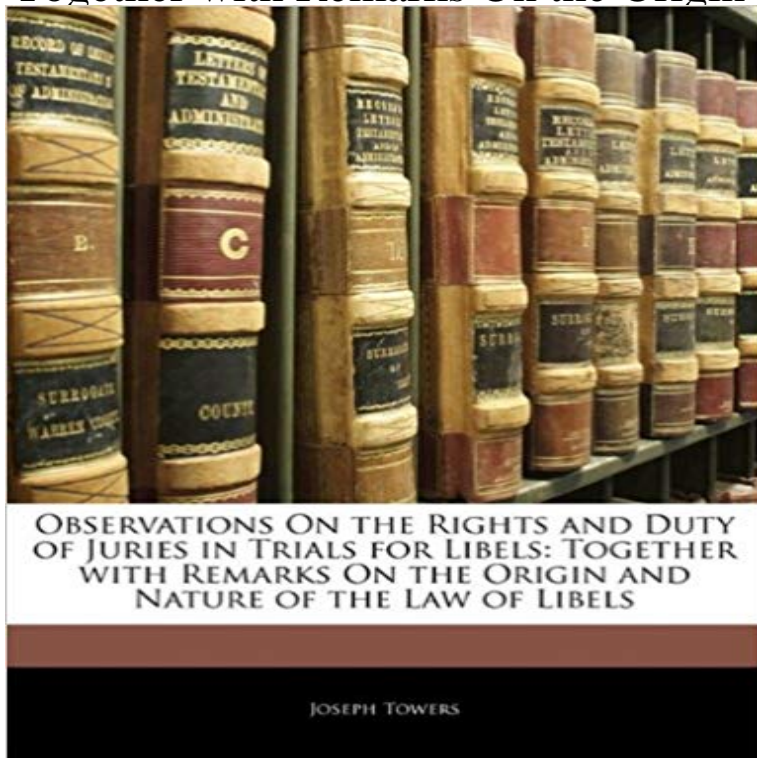


Observations On the Rights and Duty of Juries in Trials for Libels: Together with Remarks On the Origin and Nature of the Law of Libels
