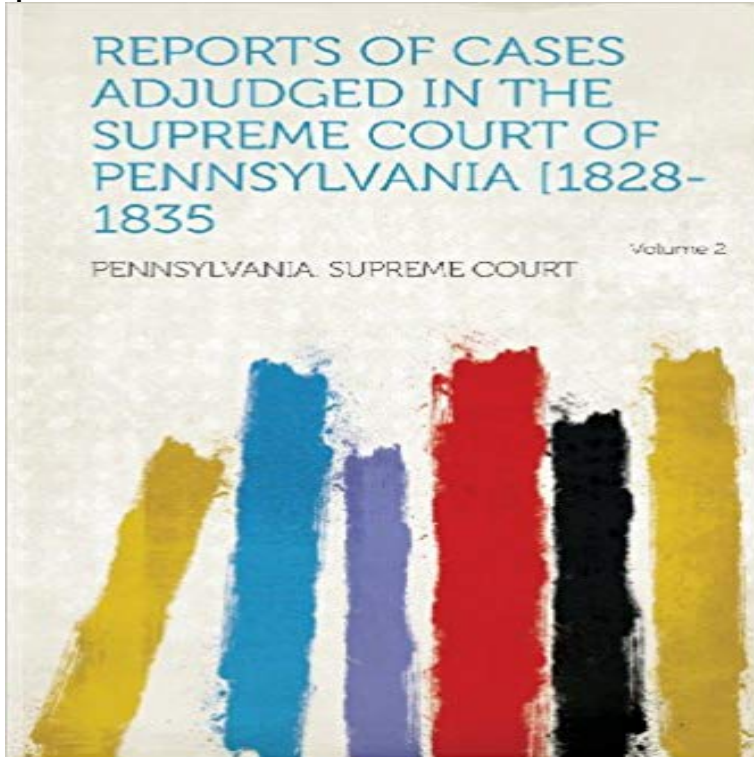


# Reports of Cases Adjudged in the Supreme Court of Pennsylvania [1828-1835 Volume 2
