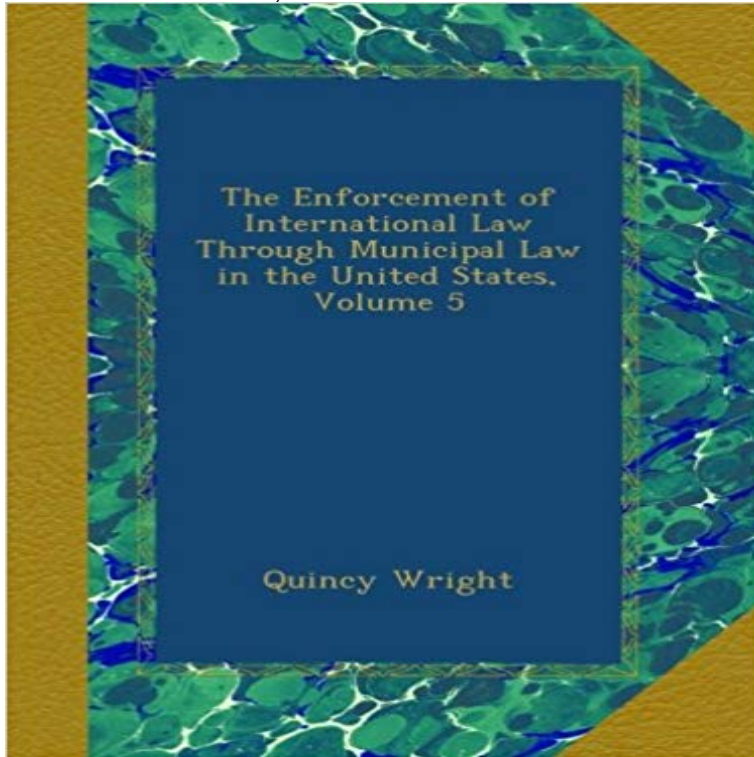


# The Enforcement of International Law Through Municipal Law in the United States, Volume 5
