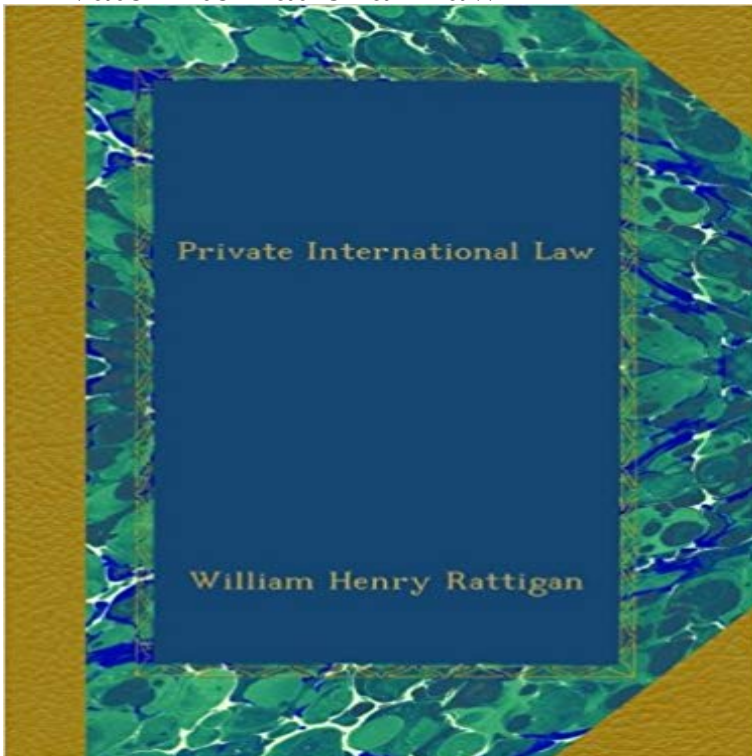


# Private International Law
